2. **EDUCATE OTHERS** - AMERICANS ARE WARY TO GET INVOLVED IN ANOTHER CONFLICT. WE SUPPORT STRONG MULTI-LATERAL ECONOMIC AND POLITICAL SANCTIONS AGAINST THE IRANIAN REGIME, SPECIFICALLY TARGETING THE OIL AND ENERGY SECTOR. IRAN NOT ONLY THREATENS ISRAEL, IT SUPPLIES AND TRAINS INSURGENTS KILLING AMERICAN SOLDIERS IN IRAQ AND AFGHANISTAN. IT ALSO DESTABILIZES THE OIL MARKET UNDERMINING OUR ECONOMY.

4. **CONTACT YOUR MEMBER OF CONGRESS** – LET THEM KNOW YOU SUPPORT THE *IRAN SANCTIONS ENHANCEMENT ACT* AND THE *IRAN COUNTER-PROLIFERATION ACT* THAT IMPOSE ADDITIONAL ECONOMIC SANCTIONS AND ENHANCE DIPLOMATIC EFFORTS TO STOP IRAN FROM ACQUIRING NUCLEAR WEAPONS CAPABILITY.
5. **DIVESTMENT** – CUTTING IRAN OFF FROM THE INTERNATIONAL BANKING SECTOR AND APPLYING TARGETED DIRECT DIVESTMENT FROM CORPORATIONS DOING BUSINESS IN THEIR ENERGY AND GAS INDUSTRIES HAVE SUCCEEDED IN DENYING IRAN MUCH NEEDED INVESTMENTS. THE STATE OF ILLINOIS LIKE OTHER STATES, CITIES AND UNIVERSITIES IN AMERICA HAVE DIVESTED THEIR PENSION FUNDS FROM COMPANIES DOING BUSINESS IN THE IRANIAN ENERGY SECTOR.
