APPLICATION COVER SHEET

The Ehrlich Student Loan program was established to assist Jewish students and their families with the cost of higher education. This Loan program was a gift to the Jewish United Fund/Jewish Federation of Metropolitan Chicago from the estate of Mrs. Shirley Ehrlich. The Ehrlich Loan will be available to Jewish students who reside in the Greater Chicago area defined as Cook, Lake, McHenry, Kane, DuPage and Will counties in Illinois. Loan eligibility will be based on financial need and those who are determined to be eligible may borrow no more than \$5,000 and no less than \$2,500 annually for four years.

This packet contains the materials required to begin the application process. It is important to read the applications carefully and provide all documents requested. The Devon Bank will administer the Ehrlich Loan and may be in touch with you during the application process.

The complete loan application process will involve two steps:

1. Submission of this application and **all required documents listed below** to the Jewish Federation of Metropolitan Chicago

- _____ Loan Application form, **fully completed** and signed
- _____ Certification of U.S. Citizenship & photocopy of documentation (passport, birth certificate, etc.)
- _____ Photocopy of Student Aid Report (SAR) (First 4 pages – both sides)
- _____ Completed and **signed** copy of applicant **and co-borrower** most recent income tax return, with attached W-2 forms
- _____ Before submission of this application, please make sure to mail the completed Certification Form to your University's Financial Aid Office.

****Please do not submit your application until you have ALL of the required documents.**

2. Submission by the Federation of your approved file to the Devon Bank who will administer and disburse all loan funds

Loans will be disbursed to your University/College at the start of each academic year. You will not be required to pay interest nor principal while enrolled as a **full-time student**. ***The interest on the loan is subsidized during the time you are a student.*** Upon graduation or completion of your program you will begin repayment. Devon Bank will provide you with a payment schedule and all necessary information to begin this process.

A completed application form (*including all requested documents*) should provide you an answer within 30 days. Delays occur when waiting for additional documents/information. Should you have questions regarding the application and its requirements, please contact *the Federation at 312/444-2867*.
