The Ehrlich Student Loan program was established in 2004 to assist Jewish students and their families with the cost of higher education. This program was a gift to the Jewish Federation of Metropolitan Chicago from the estate of Mrs. Shirley Ehrlich. The Ehrlich Loan is need-based and available to Jewish students who reside in the Greater Chicago area defined as Cook, Lake, McHenry, Kane, DuPage and Will counties in Illinois. Those deemed eligible may borrow between \$5,000 and \$10,000 annually for up to four years.

This packet contains the materials required to determine applicant eligibility. Please read all forms carefully and provide all requested documents.

REQUIRED FORMS

Please submit the following required documents only once all are complete.

1. Certification of U.S. citizenship & photocopy of documentation (passport or birth certificate).
2. Photocopy of Student Aid Report (first four pages—both sides).
3. Photocopy of driver's license (and that of co-borrower).
4. Completed and signed copy of most recent income tax return (and that of co-borrower).
5. W-2 Forms from the past two years (and that of co-borrower).
6. Copy of 2 most recent pay stubs (and those of co-borrower).
7. Self-employed applicants/co-borrowers will need to furnish 2 most recent personal and business tax returns.
8. Non-traditional applicants with no credit or limited credit will need to furnish proof of residence. Alternative credit references include verification of rent or housing expense by obtaining copies of telephone bills, utility bills, rental agreements, etc.

Before submitting the above forms, please mail the Certification Form with section A completed to your university's Financial Aid Office. Once we have received all of the above documents, we will begin to determine your eligibility.

Loans will be disbursed to your University/College at the start of each academic year. You must reapply each year you request the Ehrlich Student Loan for up to four years. You will not be required to pay interest nor principal while enrolled as a full-time student. **The interest on the loan is subsidized during the time you are a student.** Upon graduation or completion of your program, you will receive a payment schedule and all necessary information to begin repaying your loan from the lending bank.
